Dear Mr. Bekesha:

I refer you to our letter dated May 8, 2019, regarding the review of certain Department of State material under the Freedom of Information Act (the "FOIA"), 5 U.S.C. § 552. The review of potentially responsive records is ongoing, and has resulted in the retrieval of twenty-three additional documents responsive to your request. After reviewing these documents, we have determined that all twenty-three may be released to you in part. The released material is enclosed.

All non-exempt material that is reasonably segregable from the exempt material has been released. Where we have made excisions, the applicable exemptions are marked on the document. An enclosure provides information on FOIA exemptions and other grounds for withholding material.

INR has already put together some good information on both targets, so we're in much better shape than we were yesterday. Earlier this morning, we learned from USEU and Embassy London that the UK and France are expected to propose these two designations on Monday; if that happens, we expect the process to take approximately two weeks (10 working days from January 25). This timeline is shorter than usual because, as you may recall, the EU's legal authorities for autonomous Libya sanctions were finalized last summer. We will continue to track these packages and monitor how quickly Brussels is moving in the hopes that we can synchronize any rollout.

Hope this helps. As always, happy to discuss further.

The Rome meetings yesterday advanced the US, UK, and likely Italy readying to move together to offer complementary military train and equip through arms embargo exception. France appears more likely to provide non-lethal equipment only through diplomatic channels, although some French security forces might continue operating under-the-radar elsewhere (as publicly described in French press accounts). UAE visibly happy with the approach we are taking, given our position that we won't train militias, only forces under national command of GNA.

In answer to your question, our top-line goal for UNGA and the Libya Ministerial there is to praise the GNA for its C-ISIL progress in Sirte (and highlight how we've helped) and prod the international community for help rebuilding and stabilizing the city. In contrast to the political mess in Libya at last year's UNGA, there is now a government in Tripoli and ISIL has been pared back significantly on the ground. A top priority at UNGA will be to try to close the remaining political divisions - 1.4(D)

As for Operation Sophia – since 2015, the EUNAVFOR operation's mission has been to identify, capture, and dispose of migrant smuggling vessels. Last month, the EU authorized Operation Sophia to take up two additional tasks: training the Libyan coastguard and navy and helping implement the UN arms embargo off the coast of Libya. Russian envoy offers mediation in Libya

The office of Abdelrahman al-Sweihli, the head of Libya's High State Council, has issued a statement saying that he was invited to meetings supervised by Russian President Vladimir Putin, privately-owned Libyan news website Al-Wasat reported on 4 October.

Al-Sweihli received the invitation from a Russian envoy to attend meetings "to broaden the scope of the Libyan Political Agreement and to end the state of political stagnation", according to the statement.

Al-Sweihli "welcomed the Russian intiative as it is based on the political agreement" but "on the condition of taking the events before dialogue into consideration", according to the statement.

He called on Russia to "shoulder its responsibility as a major power and a permanent member of the UN Security Council and to double down on its efforts to help find piece, security and stability in Libya".
